Gold loans may soon come with EMI plans



Banks and gold loan companies are planning to introduce monthly amortisation plans after the RBI pointed out deficiencies in gold loan disbursals. Banks and gold loan companies are planning to introduce monthly amortisation plans after the Reserve Bank of India (RBI) pointed out deficiencies in gold loan disbursals. For this, the regulated entities could ask consumers to begin paying interest and principal in equated monthly instalments (EMIs) as soon as the loan resumes.

In a circular on September 30, regulator RBI pointed out irregularities in granting loans against gold ornaments and jewellery. This was after the central bank found issues in the sourcing of gold loans, valuation, due diligence, end-use monitoring, auction transparency, loan-to-value (LTV) ratio monitoring, and the application of risk weights.

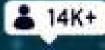

World's Largest Gold Reserve Worth \$83 Billion Discovered in China



A massive gold deposit valued at \$83 billion has been discovered in Pingjiang County, central China, potentially making it the largest gold reserve ever found. The deposit is estimated to contain about 1,000 metric tons of high-quality ore, surpassing the South Deep mine in South Africa, which holds 900 metric tons.

The Geological Bureau of Hunan Province reported that 40 gold veins have been identified at depths of up to 2 kilometers, with preliminary assessments suggesting these veins could yield around 300 metric tons of gold. Advanced modeling points to even more reserves at greater depths, possibly extending to 3 kilometers.

This discovery is expected to significantly impact China's already dominant gold industry, which contributes 10% of the world's gold output. It has also led to a surge in gold prices as global demand for the precious metal rises.

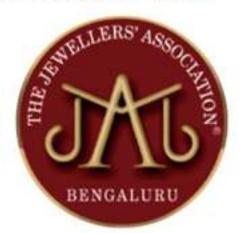


Dr Chetan Kumar Mehta re-elected as President, JAB



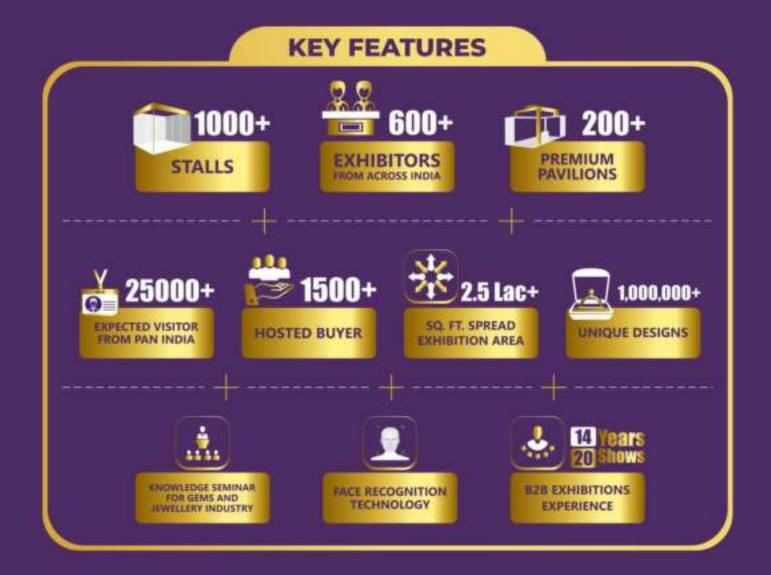

EU expressed deep disappointment over KP inaction on Russian Diamonds



The European Union (EU) has expressed deep disappointment over the failure of the Kimberley Process (KP) to address the implications of Russia's war in Ukraine on the global diamond trade, marking the third consecutive year of inaction. The EU, in a statement released on 18th November, criticised the KP's inability to confront the issue, which has significantly eroded the process's credibility and tarnished the reputation of natural diamonds.

In response to Russia's continued obstruction, the EU, in coordination with the G7, has imposed a ban on Russian diamonds to curtail Moscow's ability to finance its war effort. The EU has also proposed a robust traceability and certification mechanism to assure consumers that they are not purchasing diamonds linked to Russia's aggression. The EU strongly condemned the "unfounded allegations made by the KP Chair" against the EU's diamond ban. The EU asserted that such remarks undermine "the neutral and facilitating role expected of the Chair" and contradict the long-standing spirit of the KP.

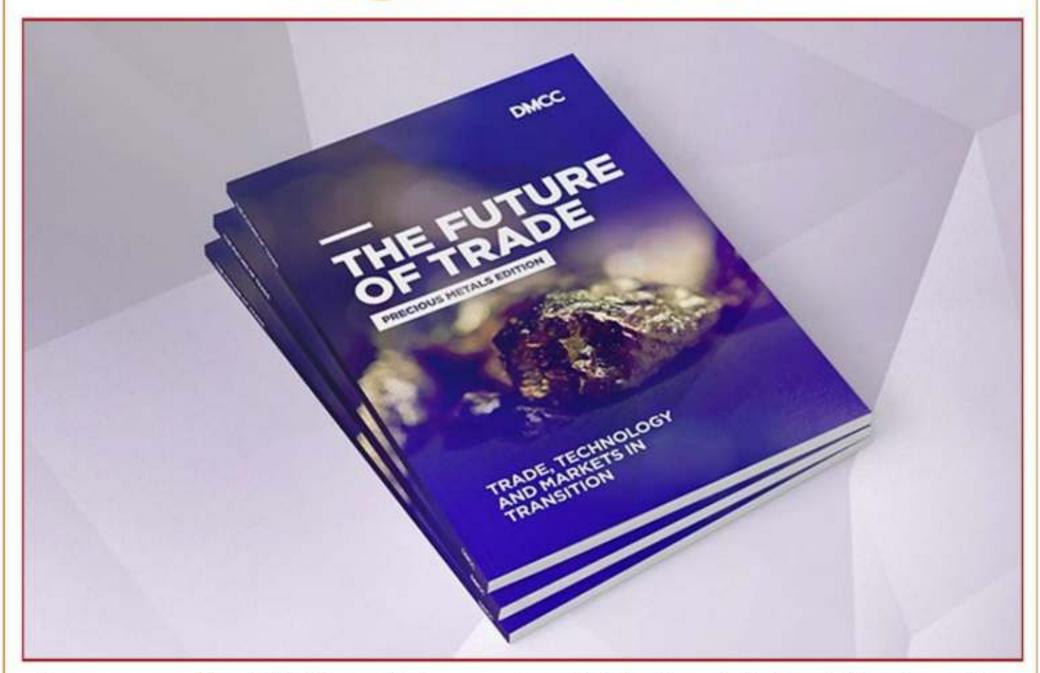

Dubai poised to lead "Asian Century" for gold trade: DMCC



A new report by DMCC predicts a major shift in the global gold trade, with Asia taking centre stage. Titled "Trade, Technology and Markets in Transition," the report highlights the rise of an "Asian Century" for gold, driven by several key factors.

One of the most significant findings is the UAE's rapid rise in the global gold trade. The report reveals that the UAE surpassed the UK in 2023 to become the world's second-largest gold hub, with a total trade value exceeding \$129 billion, a remarkable 36% increase from the previous year. This surge positions the UAE as a vital player in the future of gold trade.

The report attributes this growth to a confluence of factors, including geopolitical challenges like sanctions against Russia. These sanctions have triggered a global financial shakeup, prompting countries to diversify their reserves and reduce reliance on the US dollar. As a result, central banks worldwide have been actively buying gold, driving prices to record highs.

JGT Dubai Show confirms city as leading centre for diamond trading



The third edition of the Jewellery, Gem & Technology (JGT) Dubai show confirmed the city's status as a propitious location for diamantaires — and its potential to take over Hong Kong as the fall trade-fair destination.JGT Dubai, which took place last week, was a success for certified and loose diamond dealers. UAE diamond trade market ranked third in the world behind India and US as it is expected to reach \$40bn this year.

"There was more diamond trading than [there were] customers from the retail and jewelry side," said Ashish Garg, business head of KGK Diamonds in Dubai, adding that dealers from Israel, Belgium and India had been particularly busy on the show's first two days.

This year, the event hosted over 350 exhibitors from 25 countries. China, Hong Kong, India, Italy, Singapore, Sri Lanka, Thailand, Turkey and the US had dedicated pavilions. Among the diamond companies with booths were Choron, Hari Krishna Exports, Pace Gems, Shree Ramkrishna Exports (SRK), and Stargems.

Jewellery was most resilient core luxury category: Bain Luxury Study 2024

BAIN (9) & COMPANY

The 23rd edition of the Bain & Company Luxury Study, released in collaboration with Italian luxury goods body Fondazione Altagamma, suggests that the global personal luxury goods market is likely to dip by 2% to €363 billion in 2024.

The forecast reflects continued strength in Japan, solidity in southern Europe, and a progressively improving trajectory in the US, but also a rapid slowdown in China and challenging conditions in South Korea. Globally, the strongest category growth was found in beauty and eyewear. Jewelry was the most resilient core luxury category. Shoes and watches struggled.

The tighter conditions are polarizing the market. We estimate that only about a third of luxury brands will emerge from 2024 with positive growth, down from two-thirds a year earlier - many brands are set to suffer a drop in their revenue. In this context, pressure on profitability is mounting, setting the scene for an increased focus on performance improvement and technology in 2025.
